



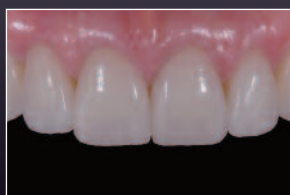

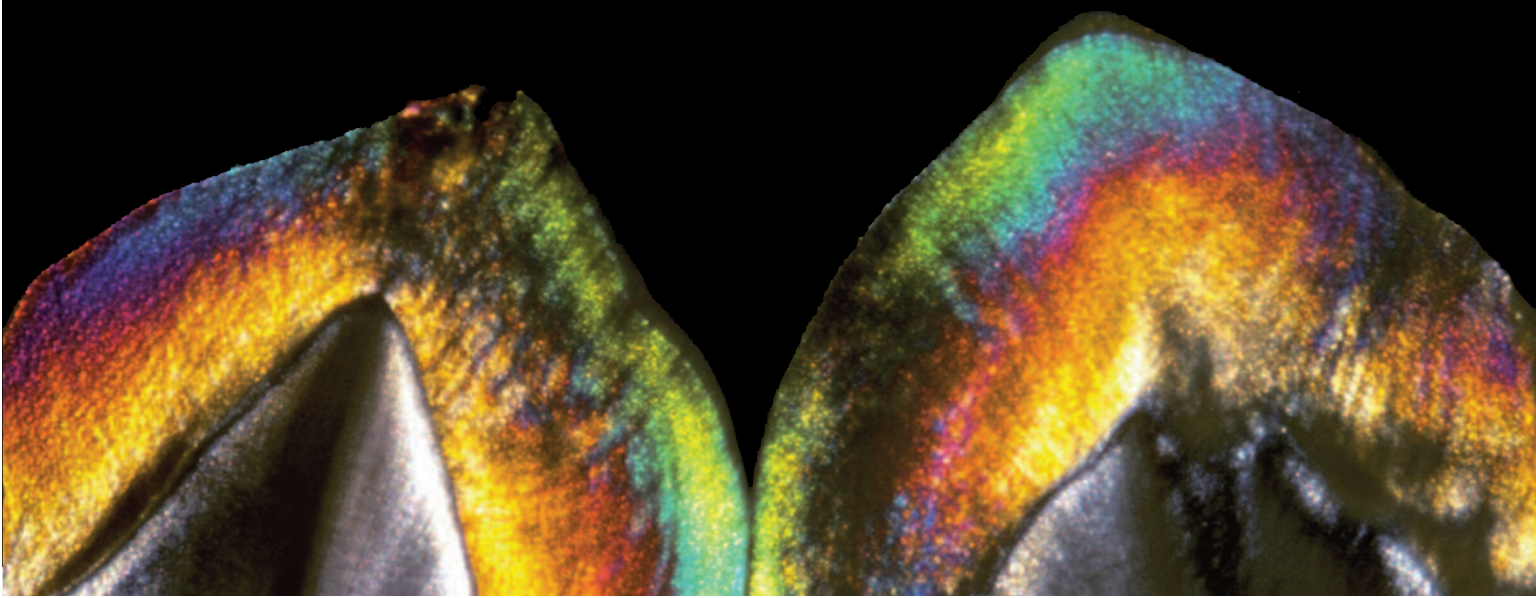

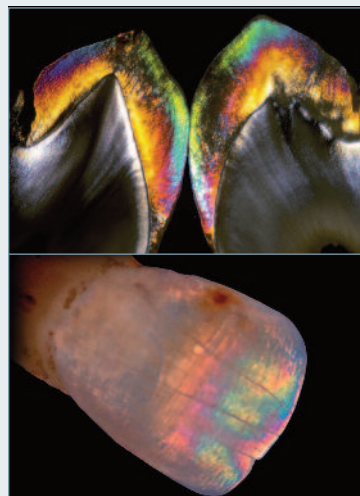
GENERAL INFORMATION

Eli Eliav

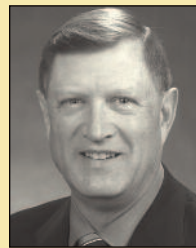

Harald O. Heymann

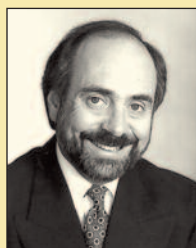

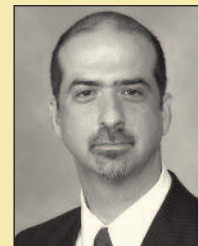
