- The publisher reserves the right to edit manuscripts to fit the space available and to ensure conciseness, clarity, and stylistic consistency, subject to the author's final approval.
- Manuscripts that do not follow these outlined instructions will be rejected promptly.

**ACCEPTABLE ARTICLES**

IJCD accepts original experimental investigations, review articles, case reports, and technique articles.

**MANUSCRIPT PREPARATION**

- Submit three typewritten copies (original and duplicates), double-spaced on one side of the paper, with at least a one-inch margin all around. Number all pages sequentially, with the title of the paper as a running header on each page. Manuscripts PC-written should be submitted on 3.5" disk as Word file. Laser print copies are needed as well.
- Authors, whose mother tongue is not English are asked to supply the manuscript in their native language together with a copy in English wherein all technical terms of the subject should be translated precisely.
- Title page. Page 1 should include the title of the article (descriptive but as concise as possible) and the name, degrees, title, professional affiliation, specific contributions to the paper, and full address of every author. Phone, fax, and e-mail address must also be provided for the corresponding author, who will be assumed to be the first-listed author unless otherwise noted. If the paper was presented before an organized group, the name of the organization, location, and date should be indicated.
- Curriculum vitae/Photo. Page 2 should include a short CV of the author(s) including photo.
- Abstract/Key words. Page 3 should include a maximum 250-word abstract. A list of 6 to 10 key words should also be included.
- Acknowledgments. Acknowledgments should be typed on a separate page. Grant or other financial support should be specified, citing the name of the supporting organization and grant number.
- Abbreviations. The full term for which an abbreviation stands should precede its first use in the text unless it is a standard unit of measurement.
- Trade names. Generic terms are to be used whenever possible, but trade names and manufacturer should be included parenthetically a first mention.

**REFERENCES**

- Type double-spaced on a separate sheet of paper.
- All references given must be cited in the text, numbered in order of appearance.
- Do not include unpublished data or personal communications in the reference list. Cite such references parenthetically in the text and include a date.
- Use the following style for literature references, keying the references to the text. Provide complete information for each reference, including names of all authors (up to six). If the reference is to part of a book, also include the title of the chapter (or part) and names of the book's editors.

**ILLUSTRATIONS**

- All illustrations must be numbered and cited in the text in order of appearance.
- On the back of each illustration, place a label with the author name(s) and figure number. Indicate the top edge lightly in pencil.
- Do not bend, fold, or use paper clips.
- For protection against damage or loss, authors should retain duplicate slides and illustrations.
- All illustrations are returned after publication.

**Black/White:** Submit three sets of high-quality glossy prints. Should the quality prove inadequate, negatives will be requested as well. Photographs should be unmounted and untrimmed.

**Radiographs:** Submit the original as well as two sets of prints.

**Color:** Color is used at the discretion of the publisher. No charge is made for such illustrations. Original slides (35-mm transparencies) must be submitted, plus two sets of prints made from them. When a series of clinical images is submitted, tonal values must be uniform. When instruments and appliances are photographed, a neutral background is best.

**Drawings:** Figures, charts, and graphs should be professionally drawn and lettered large enough to be read after reduction. Submit original art (not photocopies).

**Electronic graphs or images:** are requested as TIFF stored with 300 dpi for half-tone images and 600 dpi for line art plus laser prints. If the source cannot be recognized it should be indicated.

**Legends:** Figure legends should be grouped on a separate sheet and typed double-spaced. Detailed captions are encouraged.

## **TABLES**

Each table should be logically organized, on a separate sheet, and numbered consecutively. The title and footnotes should be included with the table.

## **COPYRIGHT RELEASE**

The following statement, signed by all authors, must accompany submitted manuscripts before they can be reviewed for publication:

In consideration of Quintessence Publishing Company taking action in reviewing and editing our submission, the authors undersigned hereby transfer, assign, or otherwise convey all copyright ownership to the publisher in the event such work is published in the International Journal of Computerized Dentistry. This assignment also applies to all translations of said article. The authors (do/do not) have a financial interest in the products, equipment, companies, etc, cited in the manuscript. Grant support or other direct or indirect involvement of a commercial interest must be disclosed in the copyright release, and should be acknowledged at the end of the article. Compliance with this disclosure request will be inferred at the time of submission of the article.

All authors are required to attest to creative participation in the preparation of the submitted manuscript.

## **PERMISSIONS AND WAIVERS**

Permission of author and publisher must be obtained for the direct use of material (text, photos, drawings) under copyright that is not the property of the authors.

Waivers must be obtained for photographs showing persons. When such waivers are not supplied, faces will be masked to prevent identification.

## **ISSUES/REPRINTS**

The corresponding author is given 2 copies of the issue and 100 free reprints of the article. If additional reprints are desired, they must be ordered from the publisher when the page proofs are reviewed by the authors. The publisher does not stock reprints; however, back issues can be purchased.
